## ALLSTATE FOUNDATION'S 2015 DRIVING CHANGE SWEEPSTAKES Official Rules

<u>Daily Entry Period Prize Winners:</u> One (1) Winner will be randomly selected each Daily Entry Period from among all eligible entries received during that corresponding Daily Entry Period upon conclusion of the applicable Daily Entry Period.
